On June 12, 2013, the Company held the Annual Meeting of its shareholders. Of the 29,632,608 issued and outstanding shares of common stock entitled to vote at the meeting, 27,710,999 of the shares voted in person or by proxy, representing 93.5% of the total eligible voting shares. The following three proposals were submitted to a vote of the Company's shareholders at the Annual Meeting and the final voting results for each proposal are set forth below.

1. The shareholders elected the sole director nominee for a term of three years. The voting results are as follows:

2. The shareholders ratified the selection of Hein & Associates LLP as independent registered public accountant firm of the Company for the year ended December 31, 2013. The voting results are as follows:
